





Para-19 appearing on page-9 of the Trust Deed is amended to read as under:-

Amendments 19.

The provisions of this deed shall not be varied, modified, deleted or amended, otherwise than as provided for under the provisions of the byelaws to be framed and approved by the Trust Board with a unanimously decision. Amendments to the Trust deed/ bye laws, rules & regulations shall be made which may be repugnant to provisions of Sec 2(15), 11, 12, 13 and 80(G) of the Income Tax Act, as amended from time to time. Further, no amendments shall be carried out without the prior approval of the Commissioner of Income Tax having jurisdiction over the trust.

Additions:

- 20. The Trust shall be irrevocable at all times.
- 21. The benefit of the trust is open to all irrespective of caste, religion creed, sex etc.


22. Investment

- 23. In case the Board of Trustees intends to run any business, the trust will satisfy the conditions stipulated in section 11(4) and proviso to section 80G(5)(1) of the income Tax Act, 1961
- 24 The Account of theTrust Shall be regularly maintained and every year, the account shall be closed by 31 st March and the same shall be audited by qualified chartered Accountant
- 25 The income and the funds of the Trust will solely be utilised for the objects and no portion of it will be utilised for payment to the trustees/members /office bearers by way of profit/ Dividend /intrest etc..
- 26 Dissolution

In the event of Dissolution of the trust net assets, if any, remaining after satisfying all the debts and liabilities shall be transferred to societies or trust registered with similar objects and registered u/s 12A of the Income Tax Act. In the absence of the same, it shall be vested with the Government under Sec 80G of the income tax act. In no case the Trust Fund shall be divided between the trustees /members.

The present capital of the Trust comes to Rs. 15,000/-.

This Amendment Deed shall be read as part and parcel of the Trust Deed No. 426 of 2006 .Stamp paper worth Rs. 2,300 /- is added to this Amendment Deed.
